The specified cost of the price for services in our Pricing Schedule will increase by the greater of 3%, any increase in CPI (All Groups, Melbourne) and any increase in the average wages of personnel concerned with the provision of home care (casual and permanent) under an applicable award or industrial instrument since the last review.

Timing:

Annually with effect from 1 July or at another date expressly set out at Part I Standard Pricing Schedule.

Other information

Standard hours are Monday to Friday (other than public holiday) 7.00am to 6.00pm, other than Care Management, where standard hours are Monday to Friday 9.00am to 5.00pm.

If GST applies to services, it will be added to the service charge. Generally services provided by Wintringham are not subject to GST.

Cost of services provided by third parties you select

Should Wintringham utilise a third party to provide services in order to give effect to a request by you, the cost of the service may differ from the Wintringham charge, and you will be notified of the cost prior to the commencement of the service.

Cancellations

If you cancel a service provided by Wintringham within one week of a scheduled service a cancellation fee equal to the service will be charged. If Wintringham has to cancel a service and you want the service provided by a third party provider instead, the cost of the service may differ from the Wintringham charge, and you will be notified of the cost prior to the commencement of the service. If you cancel a service provided by an agreed third party provider any cancellation fee charged by the provider will be on-charged.
